## **Eligibility for Fellows Consideration:**

- Membership in CIRI for a minimum of 10 years; open to all member types including corporate, consultant, vendor and retired.
- Nominations will be evaluated based on:
  - o Individual and organizational performance as an IR professional;
  - Involvement within the IR community;
  - Leadership in the IR community and among peers;
  - o Integrity/ethics/respect for others and the profession; and
  - o Innovation/advancement of/within the profession.
- Current CIRI National Directors and members of the Fellows Selection Committee are not eligible for nomination.

## **Fellows Selection Process:**

- Nominations are accepted from CIRI members; members may also self-nominate.
- Complete and send this form via email by **March 8, 2024** to Jane Maciel, CIRI Board Secretary, at jmaciel@ciri.org
- The Fellows Selection Committee will select the class of new CIRI Fellows based on the criteria above.
- The CIRI Board must approve all Fellow candidates proposed by the Fellows Selection Committee.
- New Fellows are recognized at the CIRI Annual Conference.
